**GENERAL RULES AND REGULATIONS
FOR JAMES SLAUSON COMMUNITY POOL**

All applicants please note the following rules and general information and take responsibility of understanding and complying with them.

HOURS OF OPERATION:

Group parties are welcome on Saturdays and Sundays after 4:30 p.m. Aquatic staff will clear pools and pool decks 10 minutes prior to application finish time to allow enough time to close down facility on time.

Use of water slide is an additional \$109.00. **Water Slide Security Deposit \$55.00.** All water slide users must be at least 48 inches tall.

SWIMMING RULES AND SAFETY REGULATIONS:

1. Everyone must pay to enter the pool facility, **swimming or not.**
2. Any non-swimmer or swimmer less than eight years of age must be accompanied by a parent or responsible adult 18 years or older at all times. With non-swimmers they must enter water with the child (having a bathing suit). With swimmers they must not leave facility without the child.
3. All swimmers or people entering any pools must have a proper swim suit (trunk material or net, swim suit). No T-shirts of any kind, cut off shorts, jean shorts, sweat shorts, P.E. shorts, boxer shorts, or diapers are allowed in the pools.
4. City of Azusa is not responsible for articles checked in or left in lockers or general areas.
5. Use of water slide is restricted to swimmers 48 inches or taller. Water slide user must follow lifeguards instructions. One user at a time. Users arms and legs must be crossed and held against body. User may not depart until prior user has exited the slide pool.
6. Swim test is required on all swimmers who use deep-water areas.
7. No diving in shallow water areas. **Diving off diving boards only.**
8. No smoking, outside food, drinks, chairs, radio, glass containers, body boards or personal floatation devices.
9. All lifeguard instructions must be followed. Violators of pool rules will be removed from the facility with no refund.
10. All patrons must shower before entering the pool.
11. Diving board rules - 1 bounce and straight forward.
12. Swimming allowed only while lifeguards are on duty.
13. Daily locker use is permitted with own lock. No locks may be left overnight. Locks left overnight may be cut off.
14. No running on the pool deck.
15. No horseplay, tag or splash games.
16. We are not responsible for lost or stolen items.

FOOD AND CAKE CUTTING:

Food and drinks are permitted in our New Dolphin Dining Area. No glass containers.
